Commemoration of the International Day of Persons with Disabilities 3 December 2025

THEME

Fostering disability inclusive societies for advancing social progress

BACKGROUND

World leaders have convened in Doha at the Second World Summit for Social Development (WSSD2) in November 2025 with the aim of recommitting to the Copenhagen Declaration on Social Development, to build a more just, inclusive, equitable and sustainable world. Recognising that profound social challenges confront every country, namely poverty, unemployment and social exclusion, and the urgent need to address both their underlying and structural causes, as well as their adverse consequences, the WSSD2 has served to revitalise action on advancing social progress and give momentum towards implementation of the 2030 Agenda for Sustainable Development.¹

At the conclusion of the WSSD2, we are reminded that advancing progress on social development depends on, and indeed necessitates, the inclusion of all segments of society.

Yet, across all regions, persons with disabilities face challenges and barriers in the attainment of social development objectives.² Persons with disabilities and households with person(s) with disabilities are more likely to live in poverty;³ they continue to face discrimination in employment, receiving lower wages and overrepresented in the informal sector;⁴ social protection systems are uneven in coverage and inadequate when considering extra disability-related costs, frequently excluding persons with disabilities in the informal sector;⁵ and, many persons with disabilities' experiences within care and support systems continue to be marked by the denial of their dignity, autonomy and agency.⁶

Recognising that the three core themes of social development, i.e. poverty eradication; promotion of full and productive employment and decent work for all; and social integration, are interrelated, mutually reinforcing and require an enabling environment so as to be achieved simultaneously, the inclusion of persons with disabilities as both agents and beneficiaries of social development is indispensable. Disability inclusion in all aspects of social, economic, cultural and political life is therefore an imperative.

In light of the above, critical areas for enhancing disability inclusion to advance progress in the three core themes of social development, include: community based services and support as a lever of social integration; the role of assistive technologies in expanding access to employment; the benefits of awareness-raising and eliminating discrimination to create inclusive societies; social protection as a poverty-reduction tool and driver of social inclusion; and, accessibility as an enabler of meaningful participation of persons with disabilities in decision-making processes.

means of advancing social progress and development.
