Central and Eastern Europe, the Russian Federation, Central Asia and Transcaucasia Regional Dialogue

Thursday 25 April 10:00 – 11:15

The Permanent Forum on Indigenous Issues will hold a Regional Dialogue for Central and Eastern Europe, the Russian Federation, Central Asia, and Transcaucasia during its 23rd session to meet with representatives of Indigenous Peoples and Member States. UN agencies, funds, programmes, regional and national Human Rights Institutions, and academia are welcome to attend.

The regional dialogues aim to discuss issues of relevance in the region's countries and identify how to sharpen the focus and impact of the Permanent Forum's analysis and recommendations. The objectives of these dialogues include the following:

- Identify specific issues and challenges for Indigenous Peoples in the region and share lessons learned from Indigenous Peoples, Member States, UN agencies, and other stakeholders.
- To facilitate consensus building, provide a space for Indigenous Peoples, Member States, and the UN system to exchange information and perspectives in an informal and constructive setting.
- Identify strategic measures that can be taken to advance the rights of Indigenous Peoples at all levels and highlight specific thematic areas and emerging issues that the Permanent Forum may wish to focus on at future sessions.

- Exploring the role and influence of indigenous peoples in the transition towards a greener economy
- Developing strategies for the protection and revitalization of indigenous languages as an integral part of cultural identity and rights
- The impact of conflicts on the rights and well-being of Indigenous Peoples: identifying protection measures

The dialogue will begin with introductory remarks and will be moderated by Members of the Permanent Forum of the Central and Eastern European, the Russian Federation, Central Asian and Transcaucasian region (Valentina Vyacheslavovna Sovkina, Suleiman Mamutov).

After the opening remarks, participants will be invited to reflect on the guiding themes and discuss the significant issues Indigenous Peoples encounter within the regional and national contexts of Central and Eastern Europe, the Russian Federation, Central Asia, and Transcaucasia.

Interventions from States and Indigenous Peoples should be brief and address a specific issue so that the discussions can be conducted interactively. Participants are encouraged to ask questions and not read pre-written statements.
