

We are part of a United Nations group looking at including everyone.


Our section is called the Division for Inclusive Social Development or DISD for short.

# What this paper is about



This paper gives you information about a meeting on **How to keep people with disabilities safe when wars or other disasters happen**.



It will also look at How to involve and include people better by using Easy-to-Understand communication.



Easy-to-Understand helps make sure more people know about the issues and are able to take part and be included.



The meeting will be made up of experts so it will be called the expert group meeting or EGM for short.



The information from the meeting will be used by the UN Secretary General in a report to the General Assembly on the rights of people with disabilities during wars or other disasters and using Easy-to-Understand communication to help people to be included and involved.



### **People with disabilities**

We know people with disabilities are often left out.



This is even worse during wars or other disasters.



Around the world about 1.3 billion people or 16 out of every hundred people have a disability.



## **People's rights**

The United Nations Convention on the Rights of Persons with Disabilities or CRPD for short, says countries should do all they can to keep people with disabilities safe in difficult times.



This includes:

• wars and other times of fighting



• floods or fires or other disasters



 famines, when people do not have enough to eat.



## Leaving people with disabilities out

Even with these rights, many countries do little about it.



This should start by including people with disabilities in planning for emergencies. So that people's needs are thought about and included.



Plans made without people with disabilities can leave big gaps that puts them at greater risk, pushed aside and forgotten about more.

# The problems people face around the world



### **Climate change**

Climate change is causing more and more disasters.



We know people with disabilities are affected more than others in climate change disasters. They can have:

• worse health



• die younger



more mental health issues.



### Wars and other times of fighting

During wars and other fighting, people with disabilities are often hurt more and get less help.



### Covid

During Covid we saw again that people with disabilities were treated more unfairly.




They had bigger problems getting:

# Who is coming to this expert meeting and what will they talk about?

Experts invited to the meeting include people who know about things like:

disability rights

• help and aid in emergencies



acting quickly to emergencies



• Easy-to-Understand communication.



The meeting is asked to look at 5 main questions:

 What are the difficulties in making sure people with disabilities are safe and protected in wars and other disasters? And what can be done about this?



2. What are some good ways of including people with disabilities in planning for emergencies and what countries do?



3. How can we make sure the needs and rights of people with disabilities are still seen as important even when disasters are happening?



4. What are the difficulties with Easy-to-Understand communication and how it is used? And what can be done about this?



5. What are some good examples of when Easy-to-Understand communication has been used? And what can we learn from these?



### How the expert meeting will work

The meetings will all be online using Zoom.



There will be support like sign language and CART.



The meeting will be over 3 days.



Each day will be just one session lasting 2 hours.



Each day we will have experts speaking for up to 10 minutes and then people can talk about what was said for the other 5 minutes.



### What happens next?

We will then write up about this work and what we find out for the Secretary- General to write their report.



We hope to put this in Easy Read format.




We will also put what people have said on the meetings website for people to see.
