NOTE FOR INDIGENOUS PEOPLES

The United Nations Permanent Forum on Indigenous Issues (UNPFII) is one of three UN mechanisms specifically addressing Indigenous Peoples' issues, focusing on economic and social development, culture, education, environment, health, and human rights.

The theme of the 24th session is *"Implementing the United Nations Declaration on the Rights of Indigenous Peoples within UN Member States and the UN System: Identifying Good Practices and Addressing Challenges."*

Travel arrangements, including visa procedures, are the responsibility of participating organizations. The United Nations will send a confirmation letter to pre-registered participants to the email address registered in the INDICO system, which may be used to support visa applications.

In-person Registration

Member States, the UN and other intergovernmental organizations, Indigenous Peoples' Organizations and academia accredited to the Permanent Forum and NGOs in consultative status with ECOSOC can participate in the annual session of the Forum as observers.


Registration for UNPFII 2024 is open from 24 February until 21 March 2025. Please note that late registrations will not be accepted. The designated focal point in [the Integrated Civil Society Organizations \(iCSO\) System](#) is responsible for approving the individual registrations of their delegates in the INDICO system. Additionally, focal points are kindly requested to ensure that their profile and contact information in the iCSO system are up to date to reflect the most current information about their organizations.

For all other times on April 28, 29 and 30, participants may collect their grounds passes at the UN Pass and ID Office, which is open **from 9:00 a.m. to 11:00 a.m., Monday through Wednesday.**

Please note that **in-person registration** is only available to individuals who have already registered, been approved, and received a confirmation letter of their attendance through the INDICO system. Participants must have been approved by the Conference Focal Points of accredited Indigenous Peoples' Organizations, academic institutions, or NGOs in consultative status with ECOSOC.

To collect their grounds pass, participants must present:

- **The UNPFII 2025 Confirmation Letter** sent to the email address provided in the INDICO system.
- **A valid passport** issued by a UN Member State or Observer State, or a **government-issued photo ID** for those traveling from within the United States.

Participants are kindly reminded to keep their **Temporary Grounds Pass** with them at all times during the event, as it will serve as the only valid pass for those without a UN Grounds Pass to access the UN building and conference rooms.


Location

The twenty-fourth session of the Permanent Forum on Indigenous Issues will be held at the United Nations Headquarters in New York from **21 April to 2 May 2025 in Conference Room 4.**

Opening Ceremony

The session will officially open on **Monday, 21 April 2025, from 11 am to 1 pm** in the General Assembly Hall. Access will be available from 10:00 a.m. via the ceremonial stairs or by elevator.

The opening will include a ceremonial welcome by Chief of the Onondaga Nation, Tadodaho Sid Hill, followed by statements from UN high officials, including the Secretary-General, H.E. António Guterres. The Minister of Environment of Colombia, H.E. Lena Yanina Estrada, will also address the Opening Ceremony.

Seating for Indigenous Peoples' Organizations will be available in the General Assembly Hall on a first-come, first-served basis. Please be seated under the nameplate "**Indigenous Peoples' Organizations.**"

Lists of Speakers / Interactive Dialogues

To speak at the Forum, participants can engage through two opportunities outlined in the Programme of Work: "List of Speakers" (for pre-registered observers) and "Interactive Dialogues" (open to all pre-registered observers).

Interactive Dialogues: For agenda items 5(a), 5(b), 5(c), 5(d) morning meeting, 5(e), and 5(f), there is no pre-established speaker list. Observers can request the floor at the beginning of each session by raising their hand and pressing the microphone button. Interventions may be limited to three minutes or less.

Lists of Speakers: Available to registered observers, all participants except Academia can register to speak on agenda items 3, 4, 5 (d) afternoon meeting, 5 (g), and 6. The speakers will rotate among Member States, accredited Indigenous Peoples' Organizations, and UN agencies with ECOSOC accredited NGOs as time permits.


- Representatives must sign up for the speakers list in person. You cannot sign up on behalf of another person.
- The list of speakers will be printed out and posted in CR4 shortly before each agenda item is discussed.
- The order of speakers is at the sole discretion of the PFII Chair.
- Due to time constraints, not all speakers on the list may have the opportunity to speak.



Side events will also be held at external venues; however, organizers of these events must still be accredited to the UNPFII.


