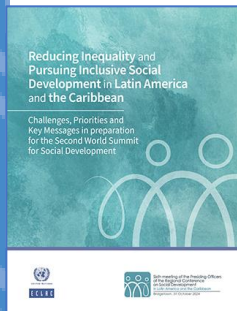
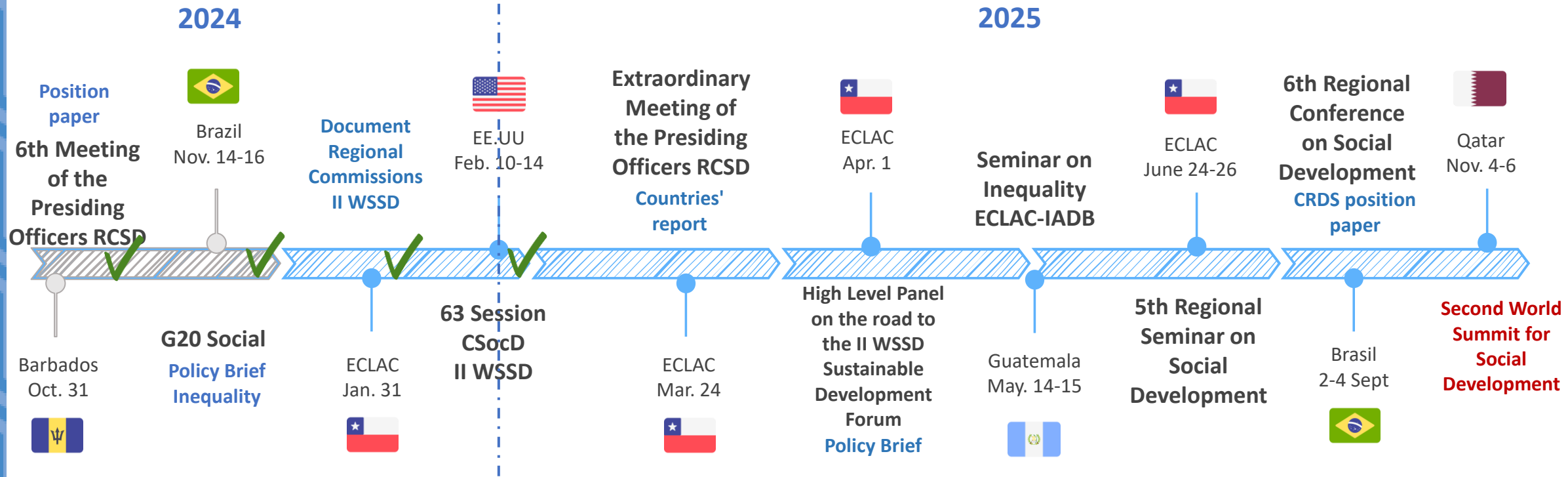

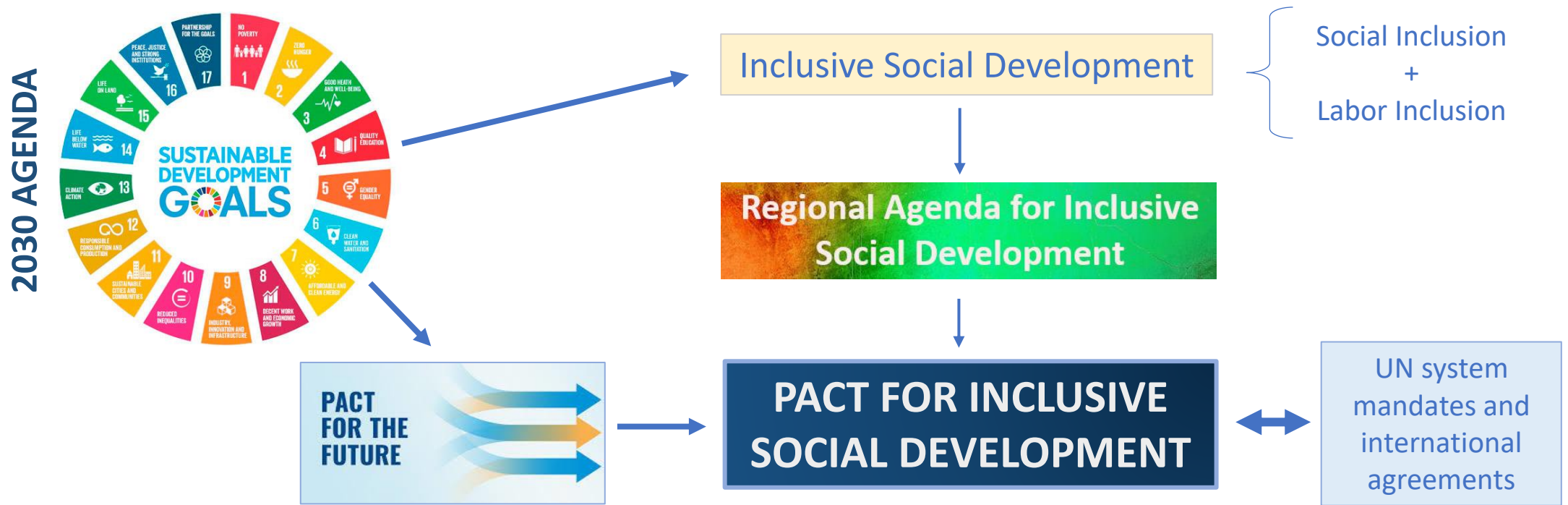

Proposal

To work for a pact for inclusive social development

In line with the Pact for the Future to achieve the SDGs



A global pact that bring together all countries with a view to strategic investment, cooperation and mutual benefit, that highlights the different rights and prioritizes actions with concrete paths and resources that allow us to take into account the obstacles and gaps that limit their achievement, with comprehensive public policies, with a horizon of universalism sensitive to differences, with financial sustainability and resilience to address the recurring crises that occur in various latitudes.

Messages

Pact for Inclusive Social Development

➤ To deal with:

1. **Poverty and hunger.** Persistent but surmountable scourges
2. **Multidimensional inequality** (income and social rights) and the emerging gaps

➤ Enhancing policies on:

1. **Social protection** systems (universal, comprehensive, sustainable and resilient)
 - Care systems and care economy
 - Public transfers and non contributory pension systems
2. **Labour inclusion:** labour market insertion with decent work
3. **Education** to enhance inclusion and youth mobility
4. **Universal health** systems transformation (primary care)
5. **Housing and urbanization** (energy, water and sanitation)
6. **Digital inclusion** – Global Digital Compact
7. **Social cohesion**, recognition and participation, and against violences

➤ Based on:

1. **Comprehensive analysis:** multidimensional inequality index and multicriteria metrics for decision making
2. Strengthening the **institutional frameworks** of social policies
3. **Financial sustainability** with expenditure standards to eradicate poverty
4. **Multilateral cooperation:** with interagency and IFI's engagement and with public-private agreements
