- It is one of my highest privilege to serve as, the pioneer Director General of Nigeria's National Senior citizens Centre, the Federal government agency with mandate to identify the needs of older persons in Nigeria and to address them with the goal of improving their quality of life and wellbeing
- It is my honour today to share the deliberate and strategic efforts of the Federal Government of Nigeria to identify and address diverse challenges of its rapidly increasing absolute numbers of older persons and to exploit the Economic Growth opportunities these presents.
- I wish to express Nigeria 's immense gratitude to UNDESA, INIA and other partners. Nigeria's policy formulation and Action Plan on Ageing has benefitted immensely from 10 years of impactful training of policy and decision makers, planners and practitioners across multi-sectors through the INIA DOF Insitu-training and the expansion of that opportunity with INIA Satellite Center for sub-Saharan Africa. In Nigeria 375 persons have been trained in Ageing Policy Formulation, Planning Implementation Monitoring and Evaluation; Gerontology and Geriatrics; Ageing and Legislative Foundations etc. UNDESA has also supported Nigeria's development of the National Plan of Action on Ageing and the National Policy Guidelines on Geriatric Social Care.

Background

- Nigeria is a very young country in terms of National population.
- Projected at 213 million in 2021 with 60% under 35 years and a median age of 18.
- However, the absolute number of older persons is rapidly increasing with 14.8 million in 2019 (NBS NLSS 2019).
- 50.2% are male and 49.8 are female.
- 5.3 million in the Urban centers while 9.5million in the Rural areas (NBS NLSS 2019).
- Nigeria has the highest population of older persons in Africa.
- The population is growing at 2.8%, and projected to be 29.8M by 2050. In that year the total population is projected at 400 m and the 3rd largest behind India & China.
- Older persons are persons 60 and above. With 60 being the mandatory retirement age for most public servants





Legislative Foundation


- Nigeria signed the National Senior Citizens Centre Act in 2017, with a mandate to identify and cater for needs of older persons- Improve the lives and well being of older persons.
- This fundamental and landmark legislation compelled the establishment of the National Senior Citizens Centre as a focal Agency on Ageing in June 2021.
- Legislation Upholds a multi sectoral approach Investments in their Capacity
 Enhancement, Continuing Engagement and economic empowerment and socia
 connections and social programs for the vulnerable.
- It directs a vision of an inclusive society, Equity, dignity, independence, health and social programs as Human right issues.






Initiating Centre


The Centre creates opportunities and solutions to advance active healthy life-styles, income security, enabling environment, life-long education opportunities, intergenerational community livelihood programmes, generation-to-generation campaigns, etc.

Advocacy Centre

The Centre sensitizes, informs, educates and mobilizes the public and relevant stakeholders to influence attitude, shift policies and engender legislative reforms in affirmation of older persons.

Resource Mobilization Centre

The Centre monitors and responds to sector policy and legislative issues that affect older persons at government/private institutions, community, traditional and faith-based institutions, in the interest of older persons through creating special purpose vehicles to mobilize needed resources and provide facilities and platforms to deliver solutions.





Developed National Policy Guidelines For Quality Assurance in Geriatric Social Care and Standard Operating Procedures For Care settings in Nigeria; Developed National Benchmark and minimum standards for Accreditation od care facilities and domiciliary care agencies

Set frameworks for quality assurance systems and mechanisms to recognize, classify, formalize, regulate and bolster CARE GIVING TO OLDER PERSONS as a fundamental component of social and economic development




CARE ECOMOMY- MAKING A BUSINESS CASE FOR CARE AND SUPPORT SERVICES

NSCC is prioritizing the productive capacities and value of the demographiecs "60 plus" by branding their unique and specialize products and services


These productive categories (retirees and pensioners) are mobilized into groups of cooperatives as economic and productive cells


NSCC provides the facilitation and coordination while communities provide the resources (human capital, land and off-takers)


EQUITY AND INCLUSION OF OLDER PERSONS' CONCERNS IN GOVERNMENT BUDGET

NSCC is committed to advocacy for equity in public spending on provision of social safety nets, social assistance and skills development across generations by providing the framework to increase social investments in older persons especially older women residing in rural council.

NSCC-NIMC Senior Citizens Multi-Purpose/Social Safety-Net cards -

- Tool for discounts, concessions and priority services in public places
- For Equity and Inclusion in National and States Social Investment Programs
- It seeks partnerships with State and local govts to deploy the Senior=Multi-purpose ID and Social safety- net cards as integral
- Nigeria is moving further to ensure its older persons have National mechanism for accessing Social assistance.
- This multipurpose card is an e- wallet that will integrate over 15 old age social assistance services for the card holders, including;
 - ✓ -Medication support
 - ✓ Nutrition & meal support
 - ✓ Social care support
 - √ mobility & transportation support
 - ✓ old age grant
 - ✓ cash transfer.
 - ✓ MultipurposeCooperatives membership support
 - ✓ -Rural artisan grant
 - √ -Subsistence farmer program grant .
- Each of the programs list the legibility indicators integrated in the chips
- NSCC and NIMC is stretching to find funds to rollout the first 1,000 050M cards in February 2025.
