## Francisco H.G. Ferreira, World Bank

Francisco H. G. Ferreira is a Senior Adviser in the World Bank's Development Research Group, where he oversees the Bank's research programs on poverty, inequality and agriculture. He was formerly the Bank's Chief Economist for the Africa Region, and has also served as Deputy Chief Economist for Latin America and the Caribbean, and as co-Director of the World Development Report 2006, on Equity and Development. Francisco is also a non-resident Research Fellow at the Institute for the Study of Labor (IZA, Bonn), and has published widely in the fields of poverty and inequality in developing countries. He was awarded the Haralambos Simeonides and the Adriano Romariz Duarte Prizes by the Brazilian Economic and Econometric Societies respectively, and the Kendricks Prize by the International Association for Research in Income and Wealth. Francisco serves on the editorial boards of the Journal of Economic Inequality (where he was previously Editor in Chief), the Review of Income and Wealth, and the World Bank Economic Review. Francisco has taught at the Catholic University of Rio de Janeiro and at the Paris School of Economics. He was born and raised in São Paulo, Brazil, and holds a Ph.D. in Economics from the London School of Economics.

#### Daouda Sembene, International Monetary Fund

Mr. Sembene is currently an Executive Director representing 23 African countries (Benin, Burkina Faso, Cameroon, Central African Republic, Chad, Comoros, Democratic Republic of Congo, Republic of Congo, Côte d'Ivoire, Djibouti, Equatorial Guinea, Gabon, Guinea, Guinea-Bissau, Madagascar, Mali, Mauritania, Mauritius, Niger, Rwanda, São Tomé & Príncipe, Senegal, and Togo) at the Executive Board of the International Monetary Fund (IMF). After joining the IMF in 2002, he took over various positions in the Research Department, the Independent Evaluation Office, and the Executive Board until 2015. Prior to assuming his current position in November 2016, he worked as an IMF Alternate Executive Director after serving for one year as a Senior Adviser to the Minister of Economy, Finance,

and Planning of his home country of Senegal. Mr. Sembene began his career as a Consultant at the World Bank in 2001, as part of a team of lecturers in macroeconomic management. Mr. Sembene holds a PhD in development economics from American University.

#### Parfait Eloundou-Enyegue, Cornell University

#### Arjan de Haan, International Development Research Centre

Arjan de Haan is Programme Leader of the Employment and Growth Programme. Before joining IDRC, Arjan worked at the Institute of Social Studies (Erasmus University Rotterdam) in The Hague, where he was convenor of the master's program in social policy and led the development of the Indices of Social Development database. He previously worked for 10 years with the UK Department for International Development in London, India, and China. He also managed the Poverty Research Unit at the University of Sussex (UK). Arjan holds a PhD in social history from Erasmus University Rotterdam., and has published widely.

#### Minquan Liu, School of Economics, Peking University

Professor Liu is a Professor of Economics at the Department of Development Economics and the Founding Director of the Center for Human and Economic Development Studies (CHEDS), Peking University. Before he joined Peking University in 2005, he was Professor of Economics at Hopkins-Nanjing Center, Johns Hopkins University, and a lecturer and research fellow with the University of Leicester and University of Cambridge. He was also a visitor to the Asian Development Bank Institute as Senior Research Fellow and Senior Capacity Building Specialist in 2011-1014, where he task-managed a project on disaster risk management (DRM) in Asia and the Pacific Region, following the Great East Japan Earthquake in March 2011. His research interest has been wide, spanning human development (principally health, education and social protection) in China and other East and Southeast Asian Economies; a broad range of issues concerning China's economic development strategy (rural institutions, rural financing and agricultural development; industrialization; foreign direct investment; poverty eradication; and environment and development); and interpretations of the recent development history of China. He has led many important research projects on the above issues and his publications have addressed these and other subject matters, and have appeared in leading Chinese and international journals. He received an M.Phil from the University of Cambridge in 1984, and a D.Phil from the University of Oxford in 1990.

#### Anis(uzzaman) Chowdhury, Western Sydney University

Anis Chowdhury is an Adjunct Professor at the Western Sydney University and Co-editor of the Journal of the Asia Pacific Economy in Australia. He was born in Chittagong, Bangladesh. Anis obtained Honours and Master's degree in Economics from Jahangirnagar University (Bangladesh) in 1976 and 1978 respectively, and M.A (1980) and Ph.D. (1983) degrees from the University of Manitoba (Canada). He joined the United Nations, Department of

Economic and Social Affairs (UN-DESA), New York as Senior Economic Affairs Officer in the Office of the Under-Secretary-General in October 2008. He was Director of Macroeconomic Policy and Development Division (July 2012-Aug. 2014) and Director of Statistics Division (Sept. 2014-May 2015) of the Economic and Social Commission for Asia and the Pacific (UN-ESCAP). Anis retired as Chief in the Financing for Development Office (UN-DESA, New York) on 31 January 2016.

#### Yuen Yuen Ang, University of Michigan

Yuen Yuen Ang is an Associate Professor of Political Science at the University of Michigan. She is also a Faculty Associate at the Center for the Study of Complex Systems and the Center for Chinese Studies at the same university. She received her PhD from Stanford University and was previously a faculty member at Columbia University's School of International & Public Affairs. Ang applies complexity economics to the study of developing economies, particularly China, with a focus on understanding how to kick-start development under adverse conditions, and strategies for fostering adaptation within governments. She is the author of "How China Escaped the Poverty Trap" (Cornell University Press, Cornell Studies in Political Economy, 2016). Ang is a winner of the 2014 GDN/Bill and Melinda Gates Foundation international essay prize on "The Future of Development Assistance." Her essay was titled "Making Details Matter: How to Reform Aid Agencies to Generate Contextual Knowledge." She was also awarded the Eldersveld Prize for outstanding research contributions by the University of Michigan. She is the first South-East Asian to be named a Public Intellectual Fellow by the National Committee of US-China Relations.

#### Azita Berar Awad, International Labour Organization

Ms. Azita Berar Awad is the Director of the Employment Policy Department (EMPLOYMENT) of the ILO which leads ILO's action for promoting full and productive employment by developing integrated employment, development and skills policies. Ms. Berar has been leading the advisory work, research and technical cooperation in the relevant fields of proemployment macro-economic policies, poverty reduction strategies, innovative employment creation schemes, youth employment, employment-intensive approaches and transitions to formality. Before her current position, Ms. Berar was the Director of the National Policy Group in the Policy Integration Department, promoting coherence of economic and social policies in pursuance of the organization's Decent Work goals in the national and international policy agendas. From 1999 to 2002, Ms. Berar Awad was the Director of the Arab States Multidisciplinary Advisory Team and the Deputy Director of the ILO's Regional Office for Arab States based in Beirut. Prior to that Ms. Berar Awad has led several technical units and programmes in the ILO responsible for research, policy analysis and technical cooperation in the areas of employment policies, poverty reduction, gender equality and targeted labour market policies.
