Through several training approaches, the project will boost the level of training in cybersecurity in Europe, improve the knowledge of staff and in turn contribute to decreased vulnerabilities against cyberthreats and increased patient trust and safety.

cen/tc 449: Quality of care for elderly people in ordinary or residential care facilities. E.D.E. became an official member of the CENT/TC 449 project. The goal of this project is to create all European standards for home and residential care.

profound: Prevention of Falls Network for Dissemination, ProFouND, is a Competitiveness and Innovation Framework Programme of the European Commission, funded thematic networking project that works with the European Innovation Partnership on Active and Healthy Ageing to bring about the dissemination and implementation of best practice in falls prevention across Europe.

interlinks: The objective of INTERLINKS (2008 – 2011) was to develop a valid system for analysing and developing long term care for the elderly. The E.D.E. was one of 20 EU organisations on the project's European advisory board, providing feedback and suggestions for improvement.
