Q2 The purpose of the organization:

MGPMU advocates for the rights and well-being of the older persons and awaken the young people about ageing and the importance of preparing for their elderly life in Uganda.

This is done through educative, advocacy and income empowerment projects.

Q3 Information as to the programmes and activities of the organization in areas relevant to the human rights of older persons:

Our programs and activities range from income empowerment projects, inter-generation programs to advocacy and awareness drives, for the following reasons

It is a fact the almost all the issues affecting the older persons in Uganda can be solved by improving their house hold incomes, and that is the main objective of one of our programms called G-MAP "60+IncomePower".

G-MAP stands for GIVE ME A PIG which is our income empowerment program and a sustainable strategic approach to improving the incomes of the older persons at home.

G-MAP improves the incomes of the older persons at a grass-root level through equipping them with skills, knowledge and the right information on how to rear profitable exotic pigs at home.

The program provides them with a Pigsty, Feeds, veterinary services, 24/7 information desk and a good breed of pigs. Through extensive monitoring, the beneficiaries of this program have the ability to earn at least 170,000 Ugandan shillings a month.

There is a very big gap between the young and the old generations, this is visible through the violations against the rights of the older persons that is mostly done by young people. In Uganda, 80% of the cases of volition of the rights of the older persons is done by young people. This is attributed to this wide gap between the young and the old generations which does not actually reflect in our cultural back ground. This is the reason behind our inter-generation programs like the YOUNG PEOPLE FOR ELDERLY PEOPLE project that includes the young people into solving the issues affecting the older persons in their communities, this in a long run bridges the gap between them and gives the young people a clear incite of how life will be when they get old.

Highlighting the needs and struggles of the older persons and rising awareness and raising up against the violation of the rights of older persons is very very paramount in the struggle to put an end to the violation of the rights of older persons in Uganda and the world at large, that is why every last Saturday of September every year which is exactly one week to the international day for older persons, we mobilize the entire country for a peaceful walk called THE ONE MILLION PEOPLE MARCH FOR THE ELDERLY. this is one of the biggest older persons processions in Kampala Uganda every year.
