	The right to access and participate in sports is recognized in several international conventions. In 1978, the United Nations Educational, Scientific and Cultural Organization (UNESCO), described this activity as a "fundamental right for all". According to the UN, however, "the right to play and practice sports has often been ignored or disrespected". In the 2000s, sport was also part of the Millennium Development Goals. In the 2030 Agenda, the General Assembly recognized the activity as "an important facilitator of sustainable development", highlighting "its promotion of tolerance and respect and contributions to the empowerment of women and young people, individuals and communities". Through cultural practices and based on the specificities of the people involved in the project, the aim is to promote cultural rescue, self-esteem and to value the practice of archery that was previously used only as a tool for hunting, fishing and in tribal wars. Today, this practice is also used as a sports alternative among the indigenous people and outside the villages when these young people are prepared to compete on equal terms with any other practitioners of the sport, taking advantage of the innate potential that these peoples demonstrate for this sport. Sport for indigenous peoples does not go alone. It is closely related to their territories, cultural identity and good living. The awakening of the harmonious relationship with nature.
	2. Cultural and sporting practices among peoples are means of promoting interethnic relations and unity among indigenous peoples, like the indigenous games that take place in Brazil.
