Q1 Name of the organization:

Costa Rican Alzheimer's Association and other Associated Dementias

Q2 The purpose of the organization:

The Costa Rican Association of Alzheimer's and other associated dementias is a non-governmental, non-profit organization of people with dementia of all ages, whose purpose is to represent, support and educate people who live with any way of life. advocacy, empowerment and support for their individual autonomy and the improvement of their quality of life.

The Costa Rican Association of Alzheimer and other Associated Dementias has been developed and promoted with the help of the Council of the Elderly, the Technical Secretary of Mental Health of the Ministry of Health and the Vice Presidency of the Republic of Costa Rica the first National Alzheimer Plan for a country of medium and low income of the world as well as the implementation of the first Plan of the Ibero-American Region since 2014 allowing the continuous improvement of human rights, the quality of life of people with dementia, their carers and their families, to reduce the impact on the regions and communities where it develops.

During the last three years of development of the National Alzheimer's Plan, we have transformed its objectives into seven transversal principles for the improvement of human development in Costa Rica, which I will detail below:

- a) Social and business responsibility in the development of the human rights of adults and older adults with dementia.
- b) Empowerment and participation of people with dementia and their caregivers.
- c) Evidence-based practices for risk reduction and dementia care with research in the public and private sectors.
- d) Multisectoral collaboration in the response of public health to dementia.
- e) Health, social and community coverage for dementia.
- f) Equity in public health responses that are applied in relation to dementia favoring gender equity
- g) Care, prevention, promotion and rehabilitation in the treatment and development of dementia care.

The number of people living with dementia around the world is expected to almost double every 20 years, reaching 131.5 million people by 2050. By 2018, the global cost of dementia will have exceeded one trillion UD dollars; much larger than the market share of companies like Google, Exxon and Apple.

Dementia is now widely recognized as one of the most important health crises of the 21st century. The absence of dementia means that governments are not prepared for the dementia epidemic and there is an urgent need for collaborative and global action to address the impact of dementia.

In May 2017, the World Health Organization adopted a global plan on dementia that targets the progress in the seven areas of awareness, risk reduction, diagnosis, care and treatment, support to care partners and research for 2025. WHO asked governments to meet the objectives for advancing awareness about dementia, risk reduction, diagnosis, care and treatment, support to care partners and research. The plan was approved at the 70th World Health Assembly this week.

Only 29 governments of the 194 member states of the WHO have developed a plan on dementia and Costa Rica is one of them.

ASCADA is made up of a volunteer group of professionals in medicine, psychology, nutrition and physical and respiratory therapy, relatives of patients and / or caregivers and former caregivers, who have been trained to clarify many doubts and give answers to the different consultations they perform. Costa Ricans who suffer the pain of caring for a family member with Alzheimer's. ASCADA has the experience and the necessary tools to support and provide psychological, therapeutic, social and medication support to family members and / or physically and mentally burdened caregivers, because when the family member knows the illness, it is much easier to provide proper treatment.

ASCADA advises and trains the caregiver so that he can manage the changes in behavior and pain suffered by the patient and his family. It prepares you to know how to act and face the long process of dealing with the sick, provides the necessary information, therapy and self-help, but, above all, conveys that love and the proper conditions of management of the patient affect their quality of life. life and in his

Q3 Information as to the programmes and activities of the organization in areas relevant to the human rights of older persons:

During the last three years of development of the National Alzheimer's Plan, Costa Rica has transformed and has been at the forefront in the care and improvement of Alzheimer's in Latin America in seven fundamental principles:

1. Human rights of people with dementia.
2. Empowerment and participation of people with dementia and their caregivers.
3. Evidence-based practices for risk reduction and dementia care with research in the public and private sector.
4. Multisectorial collaboration in the response of public health to dementia.
5. Health, social and community coverage for dementia.
6. Equity in public health responses in relation to dementia.
7. Care, prevention, promotion and rehabilitation in the treatment and development of care of the dementia.

The effective application of these seven principles has allowed us to place Costa Rica as a pioneer and leader at a global level in accordance with the strategy of attention to dementia signed by all the members of PAHO and proposed by the State of Costa Rica according to the Doctor Norbel Román president of ASCADA Active member of ADI

The actions developed have allowed to establish policies and actions in public health focused on social and community participation with a focus on respect for human rights and universal accessibility with the collaboration of the regional office of the Pan American Health Organization PAHO-WHO for mental health , aging, disability, human rights and societies.

Caretaker's House Friendly City.

Research Program 10-66. Alzheimer's and other dementias.

Ibero-American and National Congress of Alzheimer's.

Workshops, trainings, discussions and programs for the caregiver.

Regional Meetings with the Central American Confederation of Associations against Alzheimer's and associations of Ibero-America.

Development of Early Biomolecular diagnosis.

Acquisition of high technology Neuroimaging Equipment.

Access to medicines tested in Alzheimer's in the Social Security.

Developments of Community Memory Centers.

Development of Clinical Memory Centers in Social Security.

Active members of Alzheimer s Disease International.

Resolution by COMISCA declaring dementias as a mental health priority in the region

Likewise with a legal framework with the Law 8661 Approval of the rights of people with disabilities, Law 7935 Integral Law of the Elderly Person, Law 7600 Law on equal opportunities for people with disabilities and National Mental Health Policy

Q4 Confirmation of the activities of the organization at the national, regional or international level:

At the Central American level, he is the promoter of the Central American Multidisciplinary Consensus on Alzheimer's Disease and Associated Dementias, COMCAEDA, which is a world pride for having the first unified regional plan in the region and already having three ministerial resolutions of the state, on two occasions being a guest by the health ministers of the Central American area.

In the five COMCAEDA congresses since 2013 he has been the main organizer, looking for sponsor funds and specialists in each of the events.

We promote in Costa Rica as the successful venue of the IX Latin American Congress of Alzheimer's, the event being the most participatory convention related to the size of the country with more 647 participants, 90 exhibitions and more than 35 exhibitors nationally and internationally. During this event, it was the first time in history that the civil society sponsored by the Costa Rican Association of Alzheimer and other Associated Dementias invited 14 Health Ministers from Latin America to promote Alzheimer's plans.
