**Q1** Name of the organization:

Old'Up Association (French association registered under the loi 1901)

**Q2** The purpose of the organization:

Old Up is an association for the “not so young but not so old”, created by the elderly for the elderly. It has four main objectives:

- Give meaning and utility to the extended life span. Institute the notion of sustainable, creative ageing.
  - Stimulate and accompany the dynamic progression of this new generation
  - Transform the image of ageing held both by the elderly themselves and by society
  - Publish the results of the findings and become “experts” on the subject of aging.

**Q3** Information as to the programmes and activities of the organization in areas relevant to the human rights of older persons:

Old'Up is constantly in touch with human rights issues and militates to see them fully applied to the elderly. This is done in many ways, both nationally and internationally.

It is an:

- Active member of Age Platform Europe
- Active member of Age Platform France
- Active member of EURAG, the oldest federation of senior associations covering 32 European countries
- Active member of the French-speaking network of age-friendly cities (Réseau Francophone des Villes Amies des Aînés – RFVAA)
- Active participation in joint beneficiaries' committees in public hospitals to represent patients and defend their rights.

Old'Up advocates for:

- the rights of residents in senior homes (EPHAD)
  - an understanding of the different ages of “old” and the possibility of a vibrant, active old age. Ageing is not a sickness and with support and understanding should be a stage of well being and accomplishment. We subscribe to the WHO's definition of active ageing:
    - accessibility on all levels – from digital inclusion to public transport (museums, department stores and public transport authorities have turned to Old'Up to audit their facilities and report on what needs to be done to improve accessibility)
    - the right of seniors to economic security
    - strong intergenerational support.

**Q4 Confirmation of the activities of the organization at the national, regional or international level:**

- Groups: group activity is the backbone of member interaction in the association. There are 23 different groups that meet monthly. Subjects treated are varied and can be divided into four categories, the most popular being the support groups, followed by the study and information groups, field groups and finally in-house training groups. Latest additions include a group on spirituality, one on memory and one for the nonagenarians – there are already groups for the +70 and the +80 called the OctoPlus.
  - Digital literacy: training on tablets and smartphones, Internet surfing and proficiency in using the “members only” in-house digital platform
  - Scientific committee: a very active scientific committee has launched the Old’Up Collection and the first titles, both on nonagenarians, have been published. Other topics include Old’UP’s public seminars on ageing, a new seminar on ageing and psychoanalysis, work on the Oldest Old with a study of the best modes of communication and a research project on ‘soins de suite et de readaptation’ The committee is also running a project to introduce tablets to 65 nonagenarians with initiation from specially trained young job seekers who benefit by acquiring a new skill and being remunerated for the time they spend.
  - Growth and development: Old’Up’s activities have attracted interest from cities around the country including Nantes, Lyons, Marseille, Toulon, Montpellier and Brest, and a strategy of regionalisation is being implemented.
  - Communication: Old’Up’s site has been modernized and represents the full gambit of the association’s activities.
