Q1 Name of the organization:

EL-AGED CARE LTD/GTE

Q2 The purpose of the organization:

Our mission is to provide a model of comprehensive community care that incorporates medical, social, recreational rehabilitation and social work supportive care to older people in the rural areas.

To achieve our mission, we set out to deliver the following goals:

- * To provide a model of comprehensive community care that will enable older adults in the rural areas access a broad range of health and community support services. This will incorporate medical, social, supportive care, recreational rehabilitation and social work for promoting, maintaining and restoring health and active living.
 - * To create accessible and inclusive built and social environments where older adults can age in place; enjoy good health, participate actively and live safely and independently in a secure environment for as long as desired.
 - * To provide home care service; providing suitable, supervised personnel to help older persons with either health care (helping to monitor general health status and well-being, administer medications, changing dressings, etc) or personal care (bathing, dressing, and grooming) to such persons that have challenges with caring for themselves because of disability or old age.
 - * To provide the services of residential care homes that include broad care such as provide shelter, supervision, meals, and personal care to older adults in care and also assist them manage with activities of daily living.

Q3 Information as to the programmes and activities of the organization in areas relevant to the human rights of older persons:

EL-Aged Care Ltd/Gte provides a package of care depending on the needs of the client and these needs are delivered through: a) Support in the home b) Social and community programs (Adult Day Care Centre) c) Shelter / residential care service

a) Support in the home The home care support program is for those who prefer to live at home but have challenges managing day-to-day activities and tasks. The home care support includes but not restricted to support with personal care, house cleaning, laundry assistance, monitoring general health and wellbeing, social and psychological care support and respite services to carers. We also deliver in-home caregiver support program / Respite service This program is designed for those struggling with caregiving burden or needing a break. EL-Aged Care Ltd/Gte provides the needed relief to clients by ensuring respect for privacy, dignity and freedom of choice.

b) Social and community programs • Adult Day Care Centre: Adult day care service is a community-based group program, designed to provide a variety of health, social and other support related services in a friendly, safe and secure environment. The service provides opportunities for ageing family members in the community to socialize with other older adults and thus helping to avoid social isolation. The adult day care service operates during the day Mondays to Fridays. Activities of the program are conducted by trained, friendly and experienced staff that are committed to making our clients enjoy the most of their visit. Main services offered in the adult day care include: personal care provision, social care services on a consultation basis, routine health monitoring with consultation from registered medical personnel, therapeutic activities (physiotherapy), health education and promotion, supervised social activities that focus largely on social interaction.

c) Shelter / Residential care facility The shelter facility when completed will provide a long term care service that is particularly established for addressing the needs of the low-income older adults in the rural areas. The service is particularly well suitable for those who cannot live alone because of social conditions and have no family to provide care. EL-Aged Care will provide room and board type of accommodation with shared common space which includes living room, kitchen and dining for this group of older adults in a supportive home environment. The shelter service offers supportive services in the form of personal care which include activities of daily living such as bathing, dressing, and taking medications. Residents to be provided 24 hours a day, 7 days a week supervision as well as services such as meals, housekeeping, laundry, transportation, and medication management

Q4 Confirmation of the activities of the organization at the national, regional or international level:

EL-Aged Care Ltd/Gte in partnership with Africa Vision Track House Society and West African College of Surgeons (south eastern Nigeria medical outreach group) carried out a one week medical mission in Mbano from 3-10 December 2017. Mbano comprises of Isiala-Mbano local government area and Ehime-Mbano local government area. Both LGAs are in Imo State of Nigeria. 957 medical cases were treated, 291 eye glasses were dispensed, 7 eye surgeries performed, 27 general surgeries performed, 2 gynecological surgeries performed, lab tests conducted for 445 people and so many other medical and paramedical services were delivered.

Also in 2018, Divine International Nibo Nigeria (a faith based organization) in partnership with EL-Aged Care Ltd/Gte delivered a medical eye mission to Mbano which comprises of Isiala-Mbano LGA and Ehime-Mbano LGA in Imo-State from 22nd to 28th July 2018. The mission deliverables included free eye exams, surgery, eye medications and free glasses.
