Q2 The purpose of the organization:

The Association is founded on the principles and values of HelpAge International with which it shares objectives and methodologies. The Association has a democratic structure; it is not for profit and its exclusive purpose is social solidarity. It works in the social and health sectors for older people who are disadvantaged because of physical, psychological, social, financial or family circumstances. The Association promotes the autonomy, social inclusion, and physical and economic security of disadvantaged older people and fights any form of abuse against them to secure their well-being in Italy and in the world.

More specifically, the Association aims to help disadvantaged older people to claim their rights and combat the growing poverty, discrimination and low status confronting older people so that they can lead a dignified, healthy and active life.

The Association focuses on issues related to the third age such as: disaster risks reduction and climate change, rights, health, social protection, HIV/AIDS and works; also through actions to promote government policy changes and the research.

Q3 Information as to the programmes and activities of the organization in areas relevant to the human rights of older persons:

To carry out its objectives, the Association can:

- a) Promote and directly implement actions and/or projects which aim to secure social protection and assistance and to improve the conditions of disadvantaged or socially marginalised older people, either on its own or with other public or private bodies.
 - b) Undertake, alone or with other organisations, communications and awareness raising campaigns, events or other activities aimed at improving the understanding of and the well-being of older people.
 - c) Carry out policy and advocacy work within the international human rights arena to promote the inclusion of older people in both immediate and longer term humanitarian responses and in the definition of policies and guidelines aimed at securing adequate measures and guarantees for the rights of older people.
 - d) Organise cultural, sporting, artistic events and/or other activities to raise funds from both public and private sources to help achieve the organisational objectives.
 - e) Create or participate in, not for profit organisations, associations or any other type of body, national or international, including on the Board of Directors, with the aim of consolidating and developing the Association.
 - f) Design, promote and carry out directly or in collaboration with others, courses of training, seminars, conferences, events and workshops for strategic partners to protect and promote the rights of older people.
