Economic resilience firmly underpins this ongoing transformation. Despite global uncertainties, Kazakhstan's GDP continues to grow at **over six percent**, supported by steady investment and sound reforms.

Since gaining independence, our country has attracted **over 400 billion US dollars** in foreign direct investment, reflecting investor confidence in our stability and openness.

Yet we measure progress not only by economic growth, but by its social impact – by how it improves the daily lives of our citizens.

Innovation and digitalisation are key drivers in achieving that goal. Kazakhstan has emerged as a regional leader in leveraging technology to enhance governance and transparency.

Today, **90 percent** of public services are available online, contributing to greater accessibility and efficiency in government.

Our aim is to become a fully digital economy within the **next three years**, ensuring that every citizen – regardless of location or background — benefits from technological progress.

Kazakhstan's commitment to inclusive development extends beyond its national borders, reflecting our dedication to shared global progress.

This year, Almaty became the host city of the **UN Regional Centre** for the Sustainable Development Goals for Central Asia and Afghanistan – the first in our region.

Through our development agency, KazAID, and the Islamic Organisation for Food Security based in Astana, Kazakhstan actively contributes to global efforts to combat poverty and hunger.

These initiatives reflect our conviction that solidarity must be translated into concrete action.

Kazakhstan's experience demonstrates that transformation is possible even in uncertain times when it is guided by fairness, openness, and unity.

Our modernization integrates political reform, economic progress, and social development into a single, coherent vision.

As we approach the final years of the **2030 Agenda**, Kazakhstan reaffirms its unwavering commitment to the United Nations, to international cooperation, and to building a future grounded in justice and human dignity.

We fully support the **Doha Political Declaration** and stand ready to share our experience, learn from others, and contribute towards a more secure and sustainable world.

Guided by the **Charter of the United Nations**, let us work together to make that promise a reality.
